Wellness Program Terms & Conditions

Details of the Wellness Program:

- Your membership entitles you to EITHER one 90 Minute Massage Session for \$65.00 Monthly OR to one 60 Minute Massage Session for \$45.00 Monthly, that may be scheduled for anytime during that month. You MUST choose & indicate which plan you would like when signing up for the Wellness Program.
- You may receive unlimited additional massages during the month for a 5% discounted rate.
- Your Wellness Program Membership is valid only at this office.
- All Wellness sessions include approximately five minutes for Check In and Initial Consultation, as well as time to undress. All sessions conclude with approximately five minutes for Post-Consultation, guest recommendations, and time to redress. As an example, if you book a 90-minute Custom Session, this means that 80 minutes of your scheduled time will be customized hands-on treatment from an expert therapist.
- This contract is binding on both parties for the term of one year from the date signed.
- Your membership can be shared with one additional family member or friend. (If you can't make your monthly session you may send this family member/friend in your place.)
- You understand that if you are not able to visit in a particular month, you still will be charged for that month. The session will not roll over to the next month; however, you are encouraged to send the family member or friend with whom you have chosen to share your membership in your place.

Cancellation of Your Membership:

Your membership is set up month to month and will auto renew each month until you cancel.

If you chose to terminate your membership, the contract may be canceled at any time with a written 30-day notice, no reason required.

- You have canceled your appointment or not scheduled an appointment for three consecutive months in a row.
- Inappropriate behavior from the clients will not be tolerated in any manner.
- You have knowingly given false information and credit account information to process your membership properly.
